### PT AGUNG PODOMORO LAND TBK FIRST HALF 2021 RESULTS

Jakarta. August 30, 2021. PT Agung Podomoro Land Tbk ("APLN" or "the Company") – (Ticker IDX: APLN) – announced its unaudited financial results for the period ended June 30, 2021.

The Company recorded sales and revenues of IDR1,553.9 billion in 1H2021, decreased compared to IDR1,721.4 billion in 1H2020. The Company recognized sales from project development of IDR1,047.4 billion and recorded recurring revenues of IDR506.5 billion in 1H2021 as a result of the current pandemic.

The Company recorded gross profit of IDR562.2 billion with gross margin of 36.2% in 1H2021.
